

Illinois: The state witnessed a 116% increase in homelessness between

2023 and 2024, with the numbers rising from 11,947 to 25,832

individuals. Notably, approximately 91% of this increase

Chicago: The city's Point-in-Time Count estimated 18,836 individuals

experiencing homelessness on a single night in early 2024, a

substantial rise from 6,139 in 2023. This surge is largely

attributed to new arrivals from the southwest border of the U.S.


National Perspective:

Seasonality of Homelessness

Homelessness exhibits seasonal patterns, with certain periods experiencing higher numbers of individuals without stable housing.

Factors Influencing Seasonality

Weather Conditions: Harsh winters in the Midwest drive individuals to seek shelter, leading to overcrowding in urban areas like Chicago.

Economic Cycles: Seasonal employment fluctuations, especially in industries like construction and tourism, can result in temporary housing instability.

Migration Patterns: In recent years, there has been an influx of migrants seeking asylum, contributing to the rise in the unhoused population.



State Legislative Responses to Homelessness in Illinois and Indiana

Illinois: Proactive Measures and Increased Funding

Illinois has implemented comprehensive strategies to address homelessness, focusing on collaboration, funding, and legislative action:

1. HOME Illinois Initiative

Increased Funding: In the 2024 legislative session, the Illinois General Assembly allocated \$290.3 million to the HOME Illinois plan, marking a \$90 million increase from the previous year. Comprehensive Strategy: HOME Illinois emphasizes expanding affordable housing, targeting high-risk populations, and providing comprehensive support services to individuals experiencing homelessness. Illinois Government

2. Codification of Homelessness Task Forces

HB2831 Enactment: In July 2023, Governor JB Pritzker signed HB2831 into law, formally establishing the Illinois Interagency Task Force on Homelessness and the Community Advisory Council on Homelessness. These bodies work across 17 state departments and agencies to develop and implement strategies aimed at achieving functional zero homelessness in Illinois. housingactionil.org+4Illinois Government+4LegiScan+4

Leadership: The Office to Prevent and End Homelessness, led by the State Homelessness Chief Officer, coordinates efforts among state agencies, nonprofit organizations, and other stakeholders to address homelessness effectively. Illinois Government+2LegiScan+2LegiScan+2

3. Legislative Efforts to Support Vulnerable Populations

HB5407: This bill aims to strengthen supports for students experiencing homelessness by reinstating and expanding funding for homeless education, addressing the significant increase in student homelessness in recent years. Chicago Homeless

HB5564: Focused on enhancing the Homelessness Prevention Program, this legislation permits providers to allocate up to 30% of their funding for case management, ensuring individuals remain housed after receiving assistance. Chicago Homeless



Indiana: Debates Over Criminalization and Policy Approaches

Indiana's legislative approach to homelessness has been characterized by debates over policies perceived as criminalizing homelessness:<u>aclu-</u>in.org+7indianacitizen.org+7IBJ+7

1. Proposed Public Camping Ban

HB1662 Introduction: In early 2025, Indiana legislators introduced House Bill 1662, aiming to prohibit camping or sleeping on state or local government-owned property. The bill proposed penalties, including fines and possible jail time, for individuals violating the ban. WFYI+4indystar.com+4WTHR+4

Criticism and Opposition: The bill faced significant opposition from homeless advocates, legal experts, and community members who argued that it would criminalize homelessness and exacerbate the challenges faced by unsheltered individuals. <u>IBJ</u>

Legislative Outcome: Due to the controversy and widespread criticism, HB1662 did not advance in the legislative process and was effectively shelved. IBJ

2. Alternative Approaches and Advocacy

Calls for Supportive Measures: Advocates in Indiana continue to push for policies that focus on providing affordable housing, increasing shelter capacity, and offering supportive services rather than punitive measures.

Community Initiatives: Local organizations are working to implement community-based solutions, emphasizing the need for state support and funding to address the root causes of homelessness effectively.

The contrasting legislative responses in Illinois and Indiana highlight the complexities and challenges in addressing homelessness. Illinois's approach centers on increased funding, strategic planning, and supportive legislation, while Indiana's recent legislative efforts have sparked debates over the criminalization of homelessness and the need for more compassionate solutions.
