# Introduction

Pittsburgh has been grappling with a notable increase in its unhoused population, presenting challenges across various sectors. This guide provides current statistics, explores underlying causes, examines legislative responses, and discusses the impacts on healthcare, manufacturing & unionized industries, and residential security (gated communities). Additionally, it highlights how PalAmerican Security offers tailored solutions to address these challenges.



### **Current Statistics and Trends**

As of the latest data, approximately **11,000 individuals** encounter some aspect of homelessness annually in Allegheny County, which includes Pittsburgh (<u>Pittsburgh Foundation</u>). The 2024 **Point-in-Time Count** reported **1,026 individuals** experiencing homelessness, with **76% residing in shelters** (<u>Allegheny County</u> <u>Analytics</u>). Notably, there was an **8% increase** in unsheltered homelessness compared to the previous year.

## Current Statistics and Trends

#### Several factors contribute to the rising unhoused population in Pittsburgh:

**Housing Affordability and Availability:** The city faces a shortage of affordable housing, with new developments often focusing on luxury units, leading to increased rents and displacement of lower-income residents (<u>Reddit Pittsburgh</u>).

**Economic Disparities:** Widening income gaps have made it challenging for lowerincome residents to afford housing, pushing many into homelessness.

**Mental Health and Substance Use Disorders:** A significant portion of the unhoused population suffers from mental health issues and substance use disorders, hindering their ability to maintain stable housing.



#### State Legislative Responses

#### Pennsylvania and Pittsburgh have implemented measures to address homelessness:

**Zoning Amendments:** Pittsburgh's Planning Commission approved zoning changes to facilitate the development of homeless shelters and transitional housing, aiming to increase capacity and address the crisis (<u>TribLive</u>).

**Affordable Housing Initiatives:** The "500 in 500" plan, launched in June 2024, aims to provide 500 affordable housing units within 500 days. As of February 2025, 191 units have been created, and 278 individuals have secured housing (<u>Axios</u> <u>Pittsburgh</u>).
